Learning About Advocacy

On September 11th, WWA partnered with WAND to bring members of both organizations the event "Empowering Nutrition Professionals to Engage in Candidate Education".

The event featured WAND lobbyist Nathan Butzlaff and Marie Gualtieri of NWA to explain concepts of advocacy for nutrition professionals at both the state and federal levels.

Each February, NWA hosts a Policy Conference, giving education on how to advocate for the WIC program and education legislators on the importance of the work WIC staff do. Watch for conference information in the coming months if increasing your advocacy understanding is of interest to you. The conference is virtual and includes a Hill Day to meet with Wisconsin legislators or their staff

Marie Gualtieri and WWA Vice Chair, Beth Scheelk, presented a breakout session discussing NWA Priorities as well an an update and overview of the Wisconsin Taskforce on Childhood Obesity. Since WIC usually focuses on national level advocacy the introduction of how this local initiative connects to Wisconsin WIC and the work we do as an upstream approach to childhood healthy weight in Wisconsin.

WAND state policy representatives presented a breakout session to provide information and status of the WAND priority regarding Wisconsin licensure compact and professional requirements.

Current Advocacy Topics

Full Funding for Current and Prospective Participants: Soon after the FY24 budget was settled, the FY25 budget process began. As of June 10th, the appropriations for WIC, though generous, fell short of needed funding for projected FY25 caseloads.

Continue to promote the Modernization of WIC: including issues such as modernizing MIS systems, implementing online shopping, and continuation of flexible, remote service options.

Increased funding for FMNP: Many states saw significant decreases in FMNP funding. Advocate by sharing participant and farmer stories of the benefits of this program.

Full Implementation of <u>The New Food Rules</u>: In April, USDA released the Final Food Rule to update WIC food packages. The food rules were developed through a rigorous process of independent and science-based research. The concern of various lobbying groups will influence changes to the food package rules to benefit of those groups. Share your stories and the need to maintain the integrity of the food package rule.

In September the National WIC Association released the <u>2024 State of WIC Report</u> that helps to share how far WIC has come, along with supporting information for the current WIC priorities.

Advocacy Training Opportunity

2025 NWA NATIONAL POLICY VIRTUAL CONFERENCE FEBRUARY 25-FEBRUARY 27, 2025

The National Policy Conference is NWA's annual forum to highlight emerging and pressing WIC policy issues and build leadership skills to empower and sustain WIC advocacy at the local level.

The conference culminates with NWA's Annual Capitol Hill Education Day on Thursday, February 27, empowering members to virtually engage with Congressional leaders and their staff on WIC's critical services. WWA Scholarships are available for this event
